The recipient of the information provided by the participation is not Facebook, Twitter, LinkedIn or YouTube but the above-mentioned campaign manager.

The provided information will be used to contact the winner and for the delivery and administration of the prize. If the participant chooses to receive a FRITSCH newsletter, his provided information will be used for it as well. In addition, the campaign manager is allowed to contact entrants via e-mail. Questions, comments or complaints regarding this competition should be directed exclusively to the campaign manager. The campaign manager reserves the right to exclude entrants who violate the conditions of entering or who attempt to influence the campaign by technical manipulation. In the case of exclusion from the competition winnings may also be subsequently disallowed and reclaimed. The entrant is responsible for the correctness of the given contact data.
